### STORAGE INSTRUCTIONS

Store in a cool, dry place.

### COMPOSITION

Chlortetracycline 200 g/kg  
(as the stable chlortetracycline calcium complex)

### INDICATIONS

For the treatment of respiratory and other infections caused by organisms susceptible to chlortetracycline in poultry, turkeys, pigs, calves and feedlot cattle.

### WARNINGS

- ALL FEED MEDICATED WITH CHLORTET 200 G MUST BE WITHDRAWN 7 DAYS BEFORE SLAUGHTER.
- DO NOT ADMINISTER TO LAYING HENS.
- DO NOT ADMINISTER TO BREEDING ANIMALS.
- NOT FOR DIRECT FEEDING. ACCURATE MIXING IS ESSENTIAL.
- Keep out of reach of children, uninformed persons and animals.
- Although this remedy has been extensively tested under a large variety of conditions, failure thereof may ensue as a result of a wide range of reasons. If this is suspected, seek veterinary advice and notify the registration holder.

### PRECAUTIONS

- Wear protective clothing during addition of Chlortet 200 G to feed.
- Wash exposed skin after handling and before eating.
- Do not smoke or eat during use.

### DIRECTIONS FOR USE – USE ONLY AS DIRECTED

The dosage rates given below are guidelines only – the inclusion rate should be determined by a veterinarian taking into account the incidence of disease and the severity of the challenge.

This supplement must be completely dispersed throughout the total feed available to the animal at the recommended rate.

To ensure uniform dispersion in the feed it is recommended that the correct amount of CHLORTET 200 G is first mixed with 10 X its weight of feed material before blending into the final feed.

Die dosisse hieronder aangedui is slegs riglyne – toediening behoort deur 'n veearts vasgestel te word met inagneming van die siektetoestand en die erns daarvan.

Hierdie byvoegsel moet dwarsdeur die totale beskikbare voer teen die aanbevole vlak versprei word.

Om eweredige verspreiding te verseker word dit aanbeveel dat die aanbevole hoeveelheid CHLORTET 200 G eers met 10 X die hoeveelheid voer vermeng word voor dit in die finale rantsoen ingesluit word.

These are average doses suitable for routine use. In the event of severe disease challenge, levels can be safely increased on the advice of a veterinarian to give up to 600 mg

Chlortetracycline activity per kg of feed.

During treatment only Chlortetracycline-medicated feed should be used.

Treatment should be continued for a period of 5 - 7 days or longer only if directed by a veterinarian.
