STORAGE INSTRUCTIONS

Protect from extremes of heat, cold and from dampness. Store away from food and feed. Tightly reseal the container if all the contents have not been used.

WARNINGS

- DO NOT USE ON HORSES.
- DO NOT USE ON CALVES UNDER 1 MONTH.
- Withdrawal period:
 - Milk: 2 days
 - Meat: 7 days
- Signs of salivation and lethargy may occur with overdosing. These signs are transient and will pass with no ill effect.
- Keep out of reach of uninformed persons, children and animals.
- Although this remedy has been extensively tested under a large variety of conditions, failure thereof may ensue as a result of a wide range of reasons. If this is suspected, seek veterinary advice and notify the registration holder.
- **N.B.** Pyrethroid pour-ons may cause irritation. Treat a small group of animals first and observe for an hour before treating the rest of the herd.

- Verwyder en was besoedelde klere.
- Vernietig leë houters en moenie vir enige ander doel gebruik nie.
- Moenie damme, riviere en ander waterbronne besoedel nie.

GBRUIKSAANWYSINGS: GEBRUIK SLEGS SOOS AANGEDUI

- **Dose:** 1 ml / 10 kg. Treat strictly according to body mass.
- ERADITICK® CATTLE POUR-ON is a ready-to-use product and must not be mixed with any other dip, solvent or insecticidal compound.
- Apply in two lines along each side of the spine from the shoulder to the root of the tail.
- **In cases of heavy brown ear or blue tick challenge,** apply ERADITICK® CATTLE POUR-ON in two lines from the base of the skull, along each side of the spine to the root of the tail.
- **In cases of heavy red-legged tick infestation,** it may be necessary to spot-treat the affected area under the tail above the anus.
- **Treat at regular intervals according to tick challenge.** The longer the product is regularly applied, the more the tick population is reduced. It will then become possible to apply at intervals greater than 7 days.

How to use the applicator

Remove the cap of the calibrated chamber. Without removing the remaining cap, squeeze the container until the correct dosage volume is present in the calibrated chamber, and apply as prescribed

- SLEGS VIR UITWENDIGE GEBRUIK OP BEESTE
Dosis: 1 ml /10 kg. Behandel streng volgens liggaamsmassa.

- Dien die nodige dosis toe in twee strepe, vanaf die skouer langs beide kante van die ruggraat tot op die stertwortel.
- **In geval van swaar bruinoor- of bloubosluisias,** wend ERADITICK® BEES OPGIETMIDDEL aan in twee strepe vanaf die kopkroon langs beide kante van die ruggraat tot op die stertwortel.
- **In geval van swaar rooipootbosluis besmetting,** mag kolbehandeling van die geaffekteerde area onder die stert bo die anus nodig wees.

Gebruik van toediener
