SHAKE WELL BEFORE USE

PLUNGE DIP

Premix the concentrate by adding a smaller amount of water to the required quantity of product and stir continuously.
Add this cream to the diptank and mix thoroughly.

Mix as follows (1 : 1000) e.g.

Plunge dip	Water
Freshfill	1 ℥ to 1 000 ℥ water
Replenishment	1 ℥ to 1 000 ℥ water

Ensure that the animals are immersed for approximately 1 minute with the heads being submerged at least twice in order to ensure that the inside of the ears are thoroughly wetted.

JETTING

Premix the concentrate by adding a smaller amount of water to the required quantity of product and stir continuously.
Add this cream to the bulk of water and mix thoroughly.

Mix as follows (1 : 1 000) e.g.

Jetting	Water
1 mL	1 ℥
10 mL	10 ℥
100 mL	100 ℥

- Apply as a jetting spray at a rate of 3 ℥ diluted product for an average size sheep/goat. Ensure thorough wetting.
- Apply as often as necessary i.e. for prevention of blowfly strike and treatment of blowfly maggots apply every 15 – 16 weeks. Wool growth of at least 6 weeks is needed to ensure an optimal protection period.
- For lambs < 6 months of age, repeat treatment after 1 month.
- One treatment for lice infestation will suffice providing that there is NO contact with infested or untreated animals.

SHEEP SCAB MITES

Two treatments with an interval of 7 – 10 days as a plunge dip.

N.B. Sheep scab is a controlled disease in terms of the Animal Disease Act (Act 35/1984). In terms of the Act, any occurrence or suspected occurrence of sheep scab must be reported immediately to the local State Veterinarian.

DOMPELDIP

Maak 'n voormengsel deur 'n kleiner hoeveelheid water met die benodigde hoeveelheid produk te meng en roer aanhouwend. Voeg hierdie room by die afgemete volume water en meng deeglik.

Meng soos volg (1 : 1 000) bv.:

Dompendip	Water
Varsvul	1 ℥ tot 1 000 ℥ water
Aanvulling	1 ℥ tot 1 000 ℥ water

Verseker dat die diere vir ongeveer 1 minuut gedompel is, en dat hulle koppe ten minste 2 keer onderdompel word, om deeplike benetting van die binnekant van die ore te verseker.

BESPUITING

Maak 'n voormengsel deur 'n kleiner hoeveelheid water met die benodigde hoeveelheid produk te meng en roer aanhouwend. Voeg hierdie room by die afgemete volume water en meng deeglik.

Meng soos volg (1 : 1 000) bv.:

Bespuiting	Water
1 mL	1 ℥
10 mL	10 ℥
100 mL	100 ℥

- Wend aan as 'n straalspuit teen 'n koers van 3 ℥ verdunde produk vir 'n gemiddelde grote skaap/bok. Verseker deeglike benetting.
- Wend aan so gereeld soos nodig d.w.s. vir voorkoming van brommer aanvalle en behandeling van brommer maaiers, wend aan elke 15 – 16 weke. Ten minste 6 weke wolgroeい is nodig om 'n optimale periode van beskerming te verseker.
- Lammer < 6 maande oud moet na 'n maand 'n tweede behandeling ontvang.
- Een behandeling vir luis besmetting sal voldoen mits daar GEEN kontak met besmette of onbehandelde diere is nie.
