### BROAD SPECTRUM AND LONG ACTING INJECTABLE ANTIBIOTIC

#### INDICATIONS

##### For use in cattle, sheep, goats and pigs.

For the treatment of conditions caused by, or associated with oxytetracycline susceptible organisms.

- **Cattle:** Treatment of tick-borne gallsickness (anaplasmosis), heartwater, pneumonia, footrot, joint-ill, navel-ill and pink eye (infectious bovine keratoconjunctivitis).
- **Sheep and goats:** Treatment of heartwater, pneumonia, footrot, joint-ill and navel-ill.
- **Pigs:** Treatment of pneumonia, joint-ill and navel-ill.

#### COMPOSITION

Oxytetracycline 20 g/100 mℓ

#### STORAGE INSTRUCTIONS

Store at 5 – 25 °C in a dry place and out of direct sunlight.

#### DIRECTIONS FOR USE: USE ONLY AS DIRECTED

##### Administration

- **Cattle:** Not more than 20 mℓ per injection site.
- **Pigs:** Not more than 10 mℓ per injection site.
- **Sheep:** Not more than 5 mℓ per injection site.

Normally one injection is sufficient to treat disease. A second injection 3 – 5 days after the initial injection may be given if necessary. Consult your veterinarian.

##### Dosage

- **Cattle, sheep and goats**  
1 mℓ/10 kg bodymass - deep intramuscular injection.
- **Piglets up to 2kg bodymass**  
0,25 mℓ by - subcutaneous injection.
- **Piglets up to 20 kg bodymass**  
1 mℓ/animal – subcutaneous injection.
- **Pigs more than 20 kg bodymass**  
1 mℓ/10 kg bodymass - deep intramuscular injection.

### BREË-SPEKTRUM EN LANG WERKENDE INSPUITBARE ANTIBIOTIKA

#### AANWYSINGS

##### Vir gebruik in beeste, skape, bokke en varke.

Vir die behandeling van siektes veroorsaak, of geassosieer met oksitetrasiklien vatbare organismes.

- **Beeste:** Behandeling van bosluisoorge-draagde galsiekte (anaplasmose), hartwater, longontsteking, vrotpootjie, septiese gewrigsontsteking, naelstring-ontsteking en oogslymvliesontsteking (aansteeklike keratokonjunktivitis)
- **Skape en bokke:** Behandeling van hartwater, longontsteking, vrotpootjie, septiese gewrigsontsteking en naelstringontsteking.
- **Varke:** Behandeling van longontsteking, septiese gewrigsontsteking en naelstringontsteking.

#### SAMESTELLING

Oksitetrasiklien 20 g/100 mℓ

#### BERGINGSAAANWYSINGS

Berg tussen 5 – 25 °C in a droë plek weg van direkte sonlig.

#### GEBRUIKSAANWYSINGS: GEBRUIK SLEGS SOOS AANGEDUI

##### Toediening

- **Beeste:** Nie meer as 20 mℓ per inspuitplek.
- **Varke:** Nie meer as 10 mℓ per inspuitplek.
- **Skape:** Nie meer as 5 mℓ per inspuitplek.

Normaalweg is een inspuiting voldoende om siektes te behandel. 'n Tweede inspuiting 3 – 5 dae na die eerste inspuiting mag gegee word indien nodig. Raadpleeg u veearts.

##### Dosis

- **Beeste, skape en bokke**  
1 mℓ/10 kg liggaamsmassa - diep binnespiers inspuiting.
- **Klein varkies tot 2 kg liggaamsmassa**  
0,25 mℓ - onderhuidse inspuiting.
- **Klein varkies tot 20 kg liggaamsmassa**  
1 mℓ/dier – onderhuidse inspuiting
- **Varke meer as 20 kg liggaamsmassa**  
1 mℓ/10 kg liggaamsmassa - diep binnespiers inspuiting.

## WARNINGS

- DO NOT USE IN DOGS.
- DO NOT USE IN HORSES.
- TREATED ANIMALS MUST NOT BE SLAUGHTERED FOR HUMAN CONSUMPTION WITHIN 28 DAYS OF LAST TREATMENT.
- MILK FROM TREATED ANIMALS MUST NOT BE USED WITHIN 5 DAYS OF LAST TREATMENT.
- DO NOT ADMINISTER TO PIGLETS ON THE SAME DAY AS THAT THEY ARE INJECTED WITH IRON.
- Slight inflammation may occur at the injection site. This will disappear within a few days.
- Hypersensitive animals may have allergic or anaphylactic reactions. Should this occur suspend treatment and consult your veterinarian.
- Keep out of reach of children, uninformed persons and animals.
- Although this remedy has been extensively tested under a large variety of conditions, failure thereof may ensue as a result of a wide range of reasons. If this is suspected, seek veterinary advice and notify the registration holder.

**N.B.** For rapid recovery a prompt and accurate diagnosis is essential. It is, therefore, always advisable to consult your veterinarian for a correct diagnosis.

**Note:** As with all oxytetracycline solutions darkening may occur during use without affecting efficacy.
